C3872 PRAYERS

C3873 APOLOGIES

An apology for absence was received and approved from Councillor O'Brien (working).

Inspector Trott had also sent his apologies.

C3874 INTERESTS

Councillor Chin-Quee and the Town Clerk reported personal interests in Minute C3879 (Falmouth Marine School) as they were members of the Council of the Falmouth Marine School.

Councillors Mrs Davies, Evans and the Town Clerk reported personal interests in Minute C3890 (Gyllyngdune Gardens) as they served on the Gyllyngdune Project Management Board. Councillors Mrs Davies and Evans did not vote thereon.

C3875 MINUTES

It was proposed by Councillor Body, seconded by Councillor Ayres and

RESOLVED that the minutes of the Town Council meeting held on the 20th September 2010 be confirmed as a correct record of the Meeting and signed by the Chairman.

C3879 FALMOUTH MARINE SCHOOL

Mr Stedman the Head of Falmouth Marine School provided the Council with an overview of the school and future plans. The Killigrew Street site focuses upon Marine Science, Engineering and water sports and enjoyed good links with the Combined Universities in Cornwall. Currently there were 340 fulltime and a similar number of short course students. There was also provision for those with special skills or needs.

Mr Stedman responded to Councillors questions.

The Town Clerk and Councillor Chin-Quee advised the Council that they sat on the Council for Falmouth Marine School.

Mr Stedman now left the meeting.

C3882 MOTION BY COUNCILLOR STERRATT

It was proposed by Councillor Dr Sterratt, seconded by Councillor Mrs Ryan and

RESOLVED that a temporary amendment to relax Financial Regulations so as to negate the need to employ the select tender process for the toilet replacement works at Kimberley Park be approved as the tendering process had made the works unviable to date.

The Town Clerk advised that Financial Regulations were currently under review and that the relaxation should apply to this specific matter only. He had previously advised that Financial Regulations should not be relaxed in this manner.

C3883 MOTION BY COUNCILLOR SAUNBY

It was proposed by Councillor Saunby, seconded by Councillor Dr Sterratt and

RESOLVED unanimously that the Council object to the proposed relocation of the main Falmouth branch Post Office from The Moor to Market Strand on the grounds of poor accessibility for patrons and safety.

C3884 MOTION BY COUNCILLOR CRAMP

It was proposed by Councillor Cramp, seconded by Councillor Body and

RESOLVED unanimously that the Council supports The Keep Cornwall Whole Campaign and objects to the proposed Parliamentary Bill that would allow at least one 'cross-border' seat between Devon and Cornwall.

Councillor Eva advised upon other Counties that would be affected by similar proposals.

C3885 MOTION BY COUNCILLOR STERRATT

It was proposed by Councillor Sterratt, seconded by Councillor Mrs Booth and

RESOLVED that the Town Clerk write to Cornwall Council to request that they report to the Council regarding future housing provision policies for Falmouth.

The Town Clerk reported upon ongoing work regarding the Town Framework and the identifications within the recently completed Falmouth and Penryn Community Plan.

RESOLVED that the Trescobeas Recreational Area Working Party reverts to six seats and Councillor Saunby joins the current sitting Councillors (i.e. Councillors Ayres, Mrs Biggins, Body, Chin-Quee, Saunby and Sterratt (6)).

It was proposed by Councillor Mrs Biggins, seconded by Councillor Mrs Booth and

RESOLVED that the Quality Status Working Party reverts to six seats and Councillors Evans and Body, as Town Mayor and Deputy joins the current sitting Councillors (i.e. Councillors Body, Mrs Booth, Chin-Quee, Mrs Davies, Evans and Ms Merrett (6)).

It was proposed by Councillor Evans, seconded by Councillor Ayres and
