C4066 COUNCIL BUDGET AND PRECEPT CALL 2012/13

The Chairman of the Finance and General Purposes Committee presented the draft budget recommendations to the Council in respect of the Council estimates for 2012/13 that would determine the precept call. He thanked the Finance Officer for her assistance therewith. The Town Clerk reported further thereon.

It was proposed by councillor Sterratt, seconded by Councillor Mrs Ryan and

RESOLVED unanimously that the Council agrees estimates for 2012/13 as per the attached summary as recommended by the Finance and General Purposes Committee requiring a precept call of £979,468.

It was noted that this was a 0% increase in precept call from 2011/12. There had been some changes to the tax base.

C4067 THE CORNWALL COUNCIL (OFF STREET PARKING PLACES) ORDER, 2012

Pursuant to Minute F4084 this consultation had been referred from the Finance and General Purposes Committee for consideration by the Council. The Town Manager reported further thereon.

It was proposed by Councillor Ayres, seconded by Councillor Hrydziuszka and

RESOLVED that the Council responds to the consultation on the draft Order that in respect of tariffs for Falmouth Car Parks it was

- a positive move to have a cheaper short stay fee in long stay car parks, however this was diluted by the £1.70 first hour charge in short stay as the Council felt this should also be £1.
- the large difference between the two hour charge and the three hour charge would also be problematic and detrimental to shoppers in the Town.
- in respect of Sunday charging this should be a one charge all day, to prevent abuse of yellow line parking on those days.
- outside of the Order signage should also be improved to better distinguish between short stay and long stay sites.
- the Council strongly advocates payment on exit for off street sites.
