LSC214 APOLOGIES

An apology for absence was received and approved from Councillor Minson (holiday).

LSC215 INTERESTS

None declared.

LSC216 MINUTES

It was proposed by Councillor Eva, seconded by Councillor Parker and

RESOLVED that the minutes of the meeting of the Committee held on 12th March 2018 be agreed as a correct record of the proceedings and signed by the Chair.

LSC217 CORNWALL COUNCIL LICENSES

Minor Variation to Licence at the Chintz Bar, Brewery Yard, Falmouth.

The applicant advised the application form being considered by the Committee was erroneous and updated the correct detail. They wished to have recorded music between 1100 and 0000 hours (an extra hour) whilst patrons 'drank up'. At 1130 hours volume was reduced at last orders. She also wished to have drinking on the terraced area between 1000 and 1130 hours. This was currently just a smoking area.

The Police Licensing Officer had raised no objections. Members noted that an adjoining licensed premises was licenced until 0200 hours.

It was proposed by Councillor Eva, seconded by Councillor Morgan and

RESOLVED that the Council supports the variation to the licence.

Variation to Licence at Mango Tango, 6-7 Church Street, Falmouth

The applicant advised that the recently substantially refurbished premises had been taken over by him on 12th February 2018. It had been operated at weekends under temporary event notices pending this application. Significant sound proofing works had been undertaken at the direction of Cornwall Council Environmental Services Officer. Music and artists would provide entertainment upstairs for five nights per week. Downstairs would have background music only. He wished to supply alcohol 1000 to 0230 hours daily and recorded music 1000 to 0300 hours daily. He would operate the Challenge 25 policy and he apprised the Committee regarding door supervisor provision and CCTV arrangements.

The Town Clerk reported that the Police Licensing Officer raised no objection to the variation. He also reported the observations of the Town Manager.

It was proposed by Councillor Morgan, seconded by Councillor Parker and

RESOLVED that the Council supports the variation to license subject to operating the Challenge 25 policy, CCTV provision as reported and no off-sales of alcohol permitted.

There being no further business to transact the Chairman declared the Meeting closed at 5.30pm.
