Minutes of a meeting of the Licensing Committee held on Wednesday 23rd May 2018 in the Mayor's Parlour, Municipal Buildings, Falmouth at 5.00pm.

LSC226 APOLOGIES

An apology for absence was received and approved from Councillor Parker (training course).

LSC227 INTERESTS

Councillor Bonney declared a non-disclosable interest in minute LSC229(1) – Minor variation to licence, Events Square as his son was one of the sponsors of the Falmouth Beer Festival, he left the room during the consideration thereof.

LSC228 MINUTES

It was proposed by Councillor Minson, seconded by Councillor Saunby and

RESOLVED that the minutes of the meeting of the Committee held on 10th May 2018 be agreed as a correct record of the proceedings and signed by the Chair.

LSC229 CORNWALL COUNCIL LICENCES

(1) Minor Variation to Licence, Events Square, Discover Quay, Falmouth

Mr Vigus the applicant advised that a minor variation was required to allow the use of branded commemorative glasses for the annual CAMRA Kernow Beer Festival from 4th October 2018 to 6th October 2018. The premises licence stipulates plastic glasses and bottles. The Police had raised no objections and there should be no alcohol leaving the venue in glasses, so bags would be issued for glasses to leave. There would be a defined and enclosed smoking area and all bar staff to be briefed regarding Challenge 25 and not to serve those that were intoxicated.

It was proposed by Councillor Minson, seconded by Councillor Morgan and

RESOLVED that the Council fully supports the minor variation to licence subject to observance of the requirements of the Police Licensing Officer.

(2) New Licence, Stil, 11 Webber Street, Falmouth

Mr Worsick the applicant had submitted a new licence application for the sale of alcohol (on and off sales) Monday to Sunday 1000 to 2330 hours (including flexibility on New Year's Eve to continue to serve alcohol from 2300 hours to 1000 hours on New Year's Day) and late night refreshment Monday to Sunday 2300 to 2330 hours (including flexibility to provide late night refreshment on New Year's Eve from 2330 hours to 0500 on New Year's Day). Opening times of the premises are Monday to Sunday 1000 to 0000 hours (with extended opening on New Year's Eve from 0000 hours to 1000 hours on New Year's Day).

In response to questions he advised the premises would be a micro-distillery and gin school with a bar facility.

It was proposed by Councillor Morgan, seconded by Councillor Bonney and

RESOLVED that the Council does not object to the licence.

(3) Variation to Licence, The Chainlocker, Quay Street, Falmouth

Mr Jones advised that the car park area would be leased from the Harbour Master from May to October to provide additional outdoor seating for The Chainlocker and The Stable (who would sub-let). A small food hut and bar would support the operation of the premises, with a food offering that did not compete with adjoining premises. Operation would be 1200 to 2200 hours and weather dependent. The area would be barriered, manned and with waiter service.

It was proposed by Councillor Minson, seconded by Councillor Morgan and

RESOLVED that the Council does not object to the licence.

There being no further business to transact the Chairman declared the Meeting closed at 5.20pm.
